

Website terms of use

1. General

1.1 This website is owned and operated by Leg Up Learning (ABN 77 168 472 017) ("LUL", "we" or "us").

1.2 "You" or "your" means a user of the website including, in the case of any minor, the minor's parent or guardian.

1.3 Your access to this website is subject to these terms and any additional terms, notices and disclaimers which appear on this website (Terms of Use).

1.4 LUL may alter these Terms of Use from time to time without notice. Your continued use of the website following those changes indicates your acceptance of those changes.

2. Copyright
